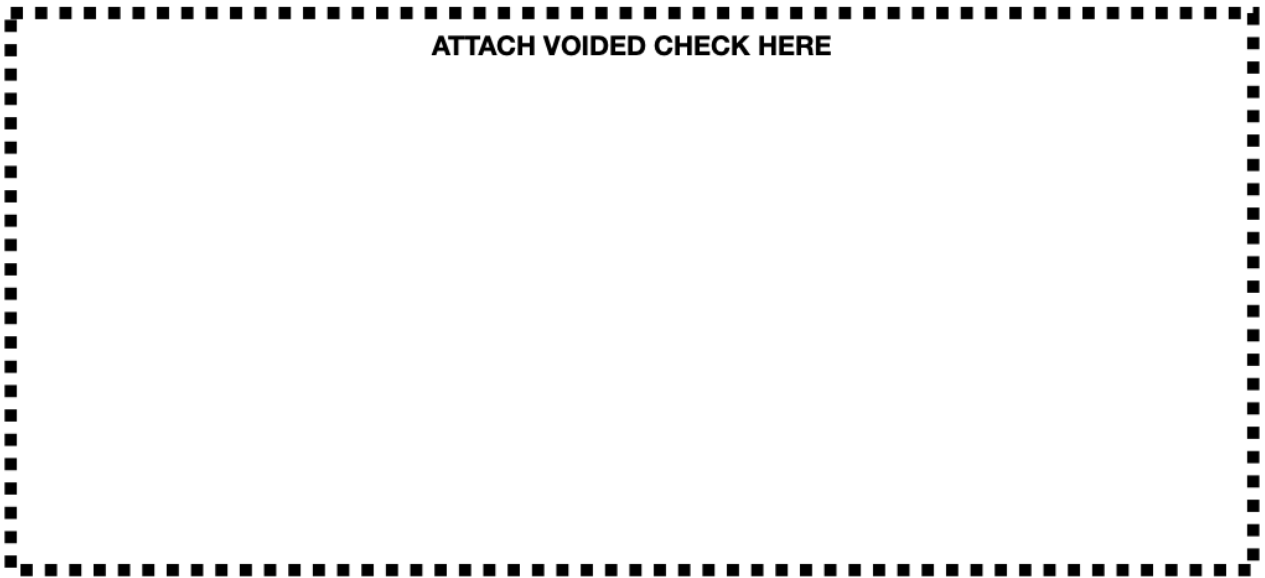

2. Receipt of Membership Plan. The undersigned hereby acknowledges receipt of the Plan for the offering of membership in Rock Creek Golf Club and the Rules and Regulations dated August 2020 (collectively, the "Membership Plan"), and agrees to be bound by all representative terms and conditions as amended from time to time.
3. Membership Privileges in the Club. The undersigned hereby knowledges that the Club facilities are owned and operated by the Club and that membership in the Club permits the member to use the facilities, but it is not an investment in the Club, nor does it confer on the member any equity ownership interested or any other property interested in the Club or the Club's facilities. Membership does not grant member a vested or prescription income of the Club and do not have a right to receive any of the Club's assets if the club is dissolved.
4. Late Fees. All payments are due on or before the 10th of the month to avoid a monthly \$25.00 late fee. In addition, all returned checks are subject to a \$35.00 dishonored check fee.
5. Payments. Payments for monthly dues and membership charges shall be by credit card or ACH draft. Any exception must be approved by the General Manager.
6. Convenience Fees. 2% of the billable member account balance or \$10, whichever is less, for use of a credit card or paper check. No fees for ACH autodraft for monthly account balance.
