**Section 5: Membership Conditions, Agreements and Declarations**

1. Approval for membership privileges. Rock Creek Golf Club is owned and operated by Golfcopartners, LLC (collectively, the “Club”). I hereby apply for membership privileges of the Club. Membership contingent upon approval, which approval shall be in the Club’s sole and absolute discretion. I agree to abide by all club rules, bylaws, and policies, including those related to conduct, dress code, and course etiquette. I understand that membership is at the discretion of the club and may be revoked for violations.

2. Membership Privileges in the Club. The undersigned hereby knowledges that the Club facilities are owned and operated by the Club and that membership in the Club permits the member to use the facilities, but it is not an investment in the Club, nor does it confer on the member any equity ownership interest or any other property interest in the Club or the Club’s facilities. Membership does not grant a member a vested or prescription income of the Club and does not have a right to receive any of the Club’s assets if the club is dissolved.

3. Late Fees. All payments are due on or before the 5th of the month to avoid a monthly late fee. In addition, all returned checks are subject to a dishonored check fee.

4. Payments. All payments for monthly dues and membership charges shall be by credit card or bank ACH draft.

5. Convenience Fees. A percentage of the billable member account balance or a flat amount, whichever is less, for use of a card or paper check. No fees for bank ACH auto-draft for monthly account balance.



6. Commitment. The undersigned hereby agrees to pay the required membership initiation fee for membership privileges in the club, plus all applicable taxes. Initiation fees payable up front or minimum commitment of 24 months from the date of this agreement.

7. Payment of Membership Dues. The undersigned hereby agrees to pay the required monthly membership dues.

8. Assumption of Risk. The undersigned acknowledges and understands that participation in golf and related activities at Rock Creek Golf Club (the "Club") involves inherent risks, including but not limited to: (i) physical injury from errant golf balls, golf clubs, golf carts, or other equipment; (ii) slips, falls, or accidents due to uneven terrain, weather conditions, or natural hazards on the golf course; (iii) exposure to wildlife, insects, or environmental elements; and (iv) potential health risks associated with physical exertion. The Member voluntarily assumes all such risks, whether known or unknown, and agrees that the Club, its officers, directors, employees, agents, affiliates, and successors (collectively, the "Club Parties") shall not be liable for any injury, damage, loss, or expense arising from or related to the Member's use of the Club's facilities, services, or participation in Club activities, except to the extent caused by the Club Parties' gross negligence or willful misconduct.

The Member further agrees to indemnify, defend, and hold harmless the Club Parties from and against any and all claims, demands, actions, liabilities, damages, costs, and expenses (including reasonable attorneys' fees) arising out of or related to: (a) the Member's breach of this Agreement; (b) the Member's negligence or misconduct; (c) injury or damage caused by the Member or the Member's guests, family members, or invitees; or (d) any violation of applicable laws or Club rules by the Member or those under the Member's supervision.

This application for Membership privileges shall be governed by and constituted in accordance with the laws of the State of Alabama without regard to principles or conflicts of law. Upon signing this application for membership privileges, I authorize references provided to furnish information to Rock Creek for investigating my qualifications for membership. I understand that acceptance for membership is conditional until full acceptance.
